



MEMORANDUM OF UNDERSTANDING BETWEEN THE UNIVERSITY OF PANNONIA AND

KAZAKH HUMANITARIAN JURIDICAL INNOVATIVE UNIVERSITY

The University of Pannonia (location: 10. Egyetem Street, H-8200 Veszprém Hungary; legal representative: Prof. Dr. András Gelencsér rector and Dr. Gyula Kovács chancellor) and Kazakh Humanitarian Juridical Innovative University (location: Mangili Yel str., 11, 071400, Semey, Kazakhstan; legal representative: Prof., Dr. Kurmanbayeva Shyryn, rector) declare that in order to enhance their research and training, they have decided to establish a mutually beneficial relationship and to work together for the purpose of furthering the studies of staff members through a reciprocal exchange programme in the field of scientific research and environmental protection with special emphasize on radiation protection, nuclear risk management, monitoring the emission sources, evaluation of environmental hazards and risks, environmental impact assessment and management of wastes.

- I. The cooperation between the two institutions undersigned would take the form of exchange of staff as well as joint research and development projects.
- II. Nothing in this Memorandum of Understanding shall be interpreted as to contravene any of the commitments entered into between each organization and its funding sources or relations with other institutions. Subjects to the availability of funds, the two institutions shall operate in the following:
 - 1. exchange of visits between members of their staff for the purpose of delivering lectures, participating in seminars, courses, studies and initiating joint research;
 - 2. encouragement of the professional staff to co-author publications;
 - 3. encouragement and initiation of joint research activities and joint in the field of outlined above.

This Memorandum of Understanding does not contravene or interfere with any actions of the University of Pannonia and Kazakh Humanitarian Juridical Innovative University toward third parties.

- III. The two institutions shall exchange visits and delegations for mutually agreed periods. The host institution shall endeavour to make available necessary facilities including the use of its facilities, laboratories and libraries.
- IV. Both institutions support the exchange of staff. The definite number of participating staff, the duration of stay, the financial conditions shall be negotiated and approved mutually by the two institutions as such specific case may arise.
- V. The two institutions shall encourage to exchange books, publications and other appropriate materials.

- VI. The two institutions shall, wherever possible participate in and exchange delegations for participation in the scientific conferences and seminars organized by them.
- VII. Delegations representing both institutions shall attempt to meet alternately (depending on the availability of funds) at each institution to discuss the following points:
 - 1. Progress and achievements in the fields of cooperation.
 - 2. Work Program for the implementation of this Memorandum of Understanding for the subsequent period.
- VIII. This Memorandum of Understanding may be altered by mutual written consent of both parties at the request of either the University of Pannonia or Kazakh Humanitarian Juridical Innovative University. Any alterations shall become effective when both parties indicate their consent in writing.
- IX. The present Memorandum of Understanding shall enter into force after signed by both parties. The Agreement is entered into force for an undefined period of time. It may be terminated by either party subsequent to a communication issued in 90 days prior to date of termination. Projects in progress at the time of termination will remain unaffected.
- X. Nothing in this Memorandum of Understanding financially obligates the University of Pannonia or Kazakh Humanitarian Juridical Innovative University. Any financial obligations arising shall be set out by the parties in a separate agreement.
