CONTRACT OF COOPERATION

Educational Institution "Kazakh Humanitarian Juridical Innovative University" (KazHJIU), represented by its Rector Shyryn Kurmanbayeva, on the one part, and Pamukkale University, represented by its Rector Huseyin Bag, on the other part, jointly referred to as the "Parties" and individually as a "Party", have entered into this Contract of cooperation (hereinafter - the "Contract") as follows:

Article 1.

The purpose of this Contract is to realize effective form of academic and scientific cooperation, creation of a single scientific environment of partners to improve the quality of higher education, and the active integration of the Parties in the global educational space.

Article 2.

With the intention of implementing the goals of this Contract, the Parties have generally agreed to cooperate with each other in the following areas:

- 1.1.Exchanges of publications and materials from implemented research, scientific and methodological literature, periodicals;
- 1.2.Organization of common bilateral symposia, seminars, conferences, scientific researches and other scientific meetings;
- 1.3.Exchanges of teachers, researchers, students of bachelor, master, doctoral degrees;

1.4.Organization of scientific cooperation in the fields of interest of both Parties;

1.5.Realization of program of academic mobility for students and teaching staff;

1.6.Elaboration and realization of joint educational programs;

1.7.Involment of scientist consultants;

1. .Cooperation in the other fields of mutual interest.

Article 3.

The details of joint activities, conditions for utilization of results achieved, and arrangements for specific visits, exchanges and other forms of cooperation will be negotiated for each specific type of activity.

Both universities agree to carry out these activities in accordance with the laws and regulations of the respective countries after full consultation and approval.

The number of students, academic staff and administrative staff who will benefit from the mobility, stated in the Article 2, will be determined by the written agreements between two parties.

The cost and expenses to be paid in relation to any cooperation or collaboration envisaged under this Memorandum shall be subject to further detail arrangements to be agreed between the Parties as and when it shall arise.

The contact and exchanges between the two parties shall be on the basis of friendship and mutual assistance.

Article 4.

The Parties have agreed that they shall endeavor to settle any discrepancies that may occur in the course of fulfillment of this Contract amicably and to as far as possible avoid any court action.

Article 5.

This Contract enters into validity and effect on the day of its signing by the statutory representatives of the Parties. It shall be effective for a period of 5 (five) years and may be extended for subsequent periods of 5 (five) years by a written agreement provided by the Parties.

Contract may be amended or modified by a written agreement signed by the representatives of two universities.

Contract may, at any time during its period of validity, be terminated by one of the universities upon prior notice to the other in writing not later than six months before the termination date.

Article 6.

This Contract is prepared in English and in two copies, one for each Party, both having the same legal force.
